Pankaj Kumar Sajita, a graduate in mining engineering from IIT(ISM), Dhanbad, with a PGDBM from XLRI, is currently working with Tata Steel Ltd. as Chief Regulatory Affairs, having blended mining operations with the framework of Safety, Health and Environment. He is a PMP-certified professional and has undergone the Indo German Manager Programme in Germany, the Global Advance Management Programme in Beijing, and the Tata Group Executive Leadership Development Program in the UK. He is a LEAD Fellow of cohort 19. He is a certified coach with Erickson Coaching International. He has more than 25 years of experience in strategic planning, project management, mine planning, mining operations, training, production, and maintenance. Under his leadership, the Vetiver plantation experiment was carried out for the first time in the Indian mining industry with the collaboration of IIT Kharagpur at Joda East mine of Tata Steel in 2012. He has been in the task force for the Sustainable Development Framework for the Indian Mining Industry, constituted by the Ministry of Mines. Under his leadership, Sukinda chromite mine of Tata Steel became the first mine in the country to pilot launch SDF (Sustainable Development Framework) and Noamundi became the first mine in the country to pilot launch Drone Application in Mine Monitoring (DAMM). He is the recipient of the FIMI Gem Granite Sustainability Award 2014-15 and the Excellent Performer Award 2015 from Legasis. He is a member of the QP & NOS committee as well as the Governing Board of the Mineral Sector Skill Council. He is the Chairman of the Delhi chapter of MEAI and Co-Chair of the FICCI mining committee. He has achieved the Best Corporate Management Innovative Excellence Award 2016-17 at the GeoMinTech Symposium, Bhubaneswar, and the Bala Gulshan Tandon Excellence Award from FIMI for his significant contribution towards assisting the mine achieve excellence through sustainable mining. He received the IME Journal’s annual award for innovation in 2017. MEAI bestowed the Service Excellence Award for his contributions to the mineral sector of the country for 2017-18 and 2019-20. He has been associated with various professional bodies and has numerous papers in national and international journals to his credit.
